<u>ORDER</u>

THIS CAUSE comes before the Court for consideration of the Receiver's Unopposed Motion to Approve Transfer of Title to the Property Located at 347 South McMullen Booth Road, #138, Clearwater, Florida 33759 (the "Property"). (Dkt. 1107) At the request of the Securities and Exchange Commission ("SEC"), the Court appointed the Receiver on February 14, 2020 and directed him, in relevant part, to "[t]ake immediate possession of all property, assets and estates of every kind of the Corporate Defendants and Relief Defendants," which includes "all real property of the Corporate Defendants and Relief Defendants, wherever situated, and to administer

such assets as is required in order to comply with the directions contained in this

Order." (Dkt. 11)

The Court previously approved the sale of the Property as part of an auction

conducted by the Receiver. (Dkt. 977) The Property was sold at auction to William

McDonald, and the Receiver requests that the Court approve the transfer of title of the

Property to William McDonald. (Dkt. 1107) The SEC consents to the relief sought in

the Motion and has waived any right to appeal this Order. (Id.) The Receiver provided

the Sale Procedures Agreement for the Court's review. (Dkt. 1107-1)

Accordingly, it is hereby **ORDERED AND ADJUDGED** that:

1. The Receiver's Motion, (Dkt. 1107), is **GRANTED**.

2. Transfer of title to the Property located at 347 South McMullen Booth

Road, #138, Clearwater, Florida 33759, better known as Pinellas County Property

Appraiser's Parcel Id Number (PIN): 16-29-16-91660-012-1380 to William McDonald

is **APPROVED.** The Property's legal description is as follows:

TRADEWINDS CONDO BLDG 12, APT 138

3. Said transfer shall be free of any and all liens and encumbrances.
